Mr. Soni continued to explain that there was a lack of teaching staff in in the field of Islamic religious education subjects, this is what makes obstacles in dealing with students taught. Because of these limitations it is necessary the addition of new teaching staff. "Actually teaching staff at school this is a lot, but for teachers of Islamic religious education subjects it is still felt not enough because student the muslim reasonable Lots so that Teacher Which There is less optimal in teaching, then the school feels a shortage of educators religion Islamic.
