This research aims to explore how these values can influence public policy in different countries, especially the Muslim majority. This research uses a literature method with an Islamic law approach. The research will begin by conducting a comprehensive literature review of primary and secondary sources, including Islamic classics, scientific journals, books on Islamic political ethics, as well as public policy articles and reports. The results of the study show that universal values such as justice ('adl), benefit (maslahah), accountability (amanah), wisdom (hikmah), and public participation (shura) have significant relevance in the context of public policy formation. These values can help create policies that are more just, inclusive, and oriented towards community welfare. However, the application of these values is inseparable from various challenges, such as

Islamic teachings as teachings that prioritize religious moderation in their concept (Kurniati, Haris, and Abd. Rahman, 2022), proven to be able to create peace in the midst of a diverse society, Islamic political ethics emphasizes the importance of justice ('adl) in the formation of public policies. Justice in Islam not only means equality before the law, but also includes the fair distribution of wealth and opportunity in society. This principle, when applied in public policy, can result in a more harmonious and prosperous society. As Al-Ghazali argued, fair policies are the key to achieving social welfare (Al-Ghazali, 2018).

In addition to justice, other values such as benefits (maslahah) are also very important. The concept of benefit in Islam refers to efforts to achieve general welfare and avoid losses. In the context of public policy, this means that the government must always consider the impact of each policy on the wider community. For example, economic policies based on the principle of benefit will focus on poverty alleviation and the provision of jobs (Al-Mawardi, 2015).

Accountability (amanah) is another very important value in Islamic political ethics. A trustworthy government is a government that is transparent and responsible to its people. As Ibn Taymiyyah suggested, accountability is the foundation of good governance (Ibn Taymiyyah, 2017).

Another relevant ethical value is wisdom (wisdom). In Islam, wisdom means making decisions based on correct knowledge and deep understanding. Public policies made with wisdom will be more effective and

With the rise of global interconnectedness and shared challenges such as climate change and economic injustice, universal values such as justice, well-being, accountability, wisdom, participation, and respect for human rights can be useful guides in the shaping of effective and sustainable public policies around the world (J Esposito, 2015).

- 7. - 6. Limited Resources: In limited resources, both in terms of finance and people. This can hinder the ability of governments to effectively apply these values in their public policies (Amina Fatima, 2019).
